Meeting Minutes

Rich Martin presided over the meeting at the Hillside Best Western at 7:00PM on Monday, August 31, 2009.

- 1. Brendan Dawson, head coach of the Aurora University lacrosse team, introduced himself and outlined the university's plans for starting a DIII lacrosse program in 2011. AU is interested in getting feedback on players, particularly current high school seniors and juniors, who have an interest in playing lacrosse at the college level.
- Bob Buckley from GLLOA (Great Lakes Lacrosse Officiating Association) presented two updates on
 officiating issues for the 2010 season. First, the GLLOA contract will be the same as the 2009 season
 and they will be sent to the schools soon. Second, GLLOA will be meeting with NISOC on Sept 28 to
 discuss issues regarding non-standard contracts to prevent the brinkmanship which occurred last
 season.
- 3. Dues will be set for \$100 per school (includes one team) and \$50 for each additional team. For example, a school with a Varsity, JV and Frosh team will pay \$100 + \$50 + \$50 = \$200 in IHSLA fees.
- 4. Paul Moretta (A.D. at Hinsdale Central) and Steve Rockrohr (A.D. at Glenbrook South) updated the group about their activities with the IHSA. Paul and Steve represented the IHSLA on Aug. 10 when they met with the IHSA administrators to argue for official sanctioning of boys lacrosse. The IHSA was interested in approving the sport for sanctioning, but wanted to see 65 Emerging Sport Agreements before they would consider approval. Paul and Steve currently have 63 ESA's and are expecting two more from Chicago Public Schools before they go back to the IHSA on Sept 18.
- 5. Paul and Steve took questions from the group regarding IHSA status. They clarified many concerns of the coaches and parent board members at the meeting. Below are a few clarifications they provided to the group.
 - a. Once a sport is IHSA sanctioned, there is no obligation for a school to support the sport. They are not obligated to participate in it, they are not obligated to fund it, they are not obligated to make it a varsity sport, they are not obligated to provide field time, to schedule games, to hire coaches, to arrange transportation, to get uniforms, etc. The decision to make the sport varsity, fund the sport, and provide support is entirely up to the school board, the administration, and the A.D. They may provide whatever support level and funding level they choose for the sport of lacrosse.
 - b. After sanctioning, the lacrosse clubs may still exist as parent-run and parent-funded clubs. Clubs will be able to play other high schools whose programs have become varsity sports, as long as the schools complete the proper sport agreements with the IHSA.
 - c. After sanctioning, the organization of the lacrosse programs across the state will run the gamut from "totally school funded and run" to "totally parent-funded and run". It is likely that most high schools will not change their policies toward lacrosse immediately. It is likely that most schools will either stay the way they are (parent-funded and parent-run) or will move to some sort of hybrid arrangement, such as limited funding and limited coaching staff. In these cases,

- the parent boards will have to share organization and funding responsibilities and augment the school's support. It is very unlikely a school would shut down the lacrosse program, especially if funding was coming from the parents.
- d. The rules and regulations pertaining to recruitment, season limits, off-season limitations, tournament play, coaching certifications and player eligibility after sanctioning will be exactly the same as they are now. All member schools of the IHSLA have signed the IHSA ESA, so they have already agreed to abide by the IHSA rules in this area.
- e. After sanctioning, some schools may totally take over the organization of the lacrosse program. The parent boards at these schools may find themselves becoming "booster clubs" which augment the expenses of the team. It is up to the individual schools to determine how the booster clubs operate (in aggregate for all sports or individually for each sport). The parents involved in the booster clubs must work with the schools A.D. to figure out how they will share responsibilities. School booster clubs must abide by the IHSA rules regarding recruitment, offseason activities, and season limits (just as the parent boards do now).
- f. After IHSA sanctioning, there is no reason for the schools to replace outside qualified coaches with teachers. A.D.'s in public schools with union contracts must make sure that teachers who are more qualified than outside coaches are not being denied coaching opportunities.
- g. After sanctioning, the IHSA runs the state championship tournament. The IHSA schedules it, the IHSA seeds it, and the IHSA gets revenue from the playoff games and the championship game. Under an IHSA structure, there is only one class of schools until there are more than 300 schools in the league, at which point they break down into two classes. The playoff brackets are generally determined regionally. The regional winners advance to play the other regional winners. Notice that this arrangement does not necessarily result in the two best teams playing each other in the championship game. For lacrosse, the IHSA will follow the same playoff and championship format they use for all other IHSA sports. It is unlikely they will make special rules for lacrosse like they do for football or baseball.
- h. The IHSA does not care how the conferences are determined. The IHSA is conference-blind when it comes to running the state championship tournament. The conferences exist for the convenience of the A.D.'s to schedule local games for multiple sports. The IHSLA is rearranging the lacrosse conference structure to better match the IHSA conference structure so it is easier for the A.D.'s to schedule and discuss lacrosse activities.
- i. After sanctioning, the IHSA certifies referees. In the sport of lacrosse, the IHSA requirements are well below the current requirements for lacrosse referee certification. GLLOA will work with the IHSA to consider stricter certification requirements to prevent unsafe lacrosse play.
- j. Some of the coaches were worried that the one-class IHSA structure would remove the incentive for B-class teams to get better. The A.D. reps suggested the IHSLA conduct their own Class-B tournament to crown a lower tier champion to keep the motivation alive.
- 6. The IHSLA is changing the conference structure to better align with other sports. The new conference structure is attached. Each team must play at least 5 games within their conference. Scheduling begins immediately for conference games. All conferences schedules must be completed by Sept. 15. No non-conference games may be scheduled before conference games are scheduled. All conference schedules must be submitted by a conference scheduler to Linda Bertelson at Lacrosse America.

- 7. Non-conference game scheduling will begin Sept 15 and must be finished by Oct. 5. All non-conference schedules must be submitted by the school to Linda Bertelson at Lacrosse America.
- 7. The group separated into their new conferences to assign responsibilities. Each conference selected a conference scheduler and an executive board member (attached).
- 8. The next meeting is scheduled for Jan 25, 2010 at 7:00PM in the Hillside Best Western. An interim meeting will be scheduled on Oct 5 at a location to be determined later to facilitate non-conference scheduling.
